



Christie Mountain Snow Area COMPETITION RELEASE OF LIABILITY

Of my own free will, I hereby agree to enter and compete in a competition at Christie Mountain Snow Area under the terms contained herein.

I accept and understand that the sport of skiing/snowboarding and this competition involve certain inherent and other risks, dangers and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence in this sport and this competition. Risks include, but are not limited to, risk of injury or death from changes in terrain and snow surfaces, ice, moguls, bare spots, debris, fences, posts, trees, lift equipment and towers, light poles, signs, buildings, roads and walkways, ramps, padded and non-padded barriers, half-pipes and other terrain features, grooming equipment, snowmobiles, collisions with other skiers/snowboarders and any and all other objects and hazards both natural and man-made. **I FREELY ACCEPT AND ASSUME ALL RISKS OF INJURY ASSOCIATED WITH SKIING/SNOWBOARDING AND THIS COMPETITION.**

I represent and agree that I possess the necessary skills and physical ability to compete in this competition in such a manner that I will not endanger myself, other competitors, spectators or other persons. I understand that as a skier/snowboarder, I am bound by certain Wisconsin state laws and the Skier Responsibility Code (known as "Your Responsibility Code"). I understand and agree that it is my responsibility to inspect the course and terrain prior to attempting to compete, to avoid falls and collisions, and to avoid injury to myself and others. I understand and agree that I am responsible for the inspection and maintenance of my equipment, including skis, snowboards, bindings, boots, poles and restraint devices or leashes. I agree that I will use restraint devices and/or leashes at all times. I further understand that no inverted aerial maneuvers are allowed. I agree that any photos captured of myself while at Christie Mountain may be used for advertising purposes.

In consideration of the permission to compete in this competition, **I hereby RELEASE AND FULLY DISCHARGE Christie Mountain Snow Area, Christie Mountain Ski School, Christie Mountain Snowboard School, Team Christie, their affiliates, owners, officers, directors, shareholders, coaches, sponsors, agents and employees from any and all liability resulting from any personal injury to myself, including my death, or damage to my property, which is caused in any way by the BREACH OF ANY EXPRESS OR IMPLIED WARRANTIES or the NEGLIGENCE ACTS OR OMISSIONS of Christie Mountain Snow Area, Christie Mountain Ski School, Christie Mountain Snowboard School, Team Christie, or any of their affiliates, owners, officers, shareholders, coaches, sponsors, agents or employees in the preparation, organization, coordination, operation and/or supervision of the competition; in the preparation, design, location, installation, setting, maintenance, operation, inspection and/or supervision of the race course(s); and/or in the instructions given or not given to me concerning the competition, the race course(s) or any part thereof or from any other NEGLIGENCE ACT OR OMISSION whatsoever.** I accept for myself full responsibility for any and all injuries or damages of any kind which may result from the participation in this competition, and it is my intention to **HOLD HARMLESS** Christie Mountain Snow Area, Christie Mountain Ski School, Christie Mountain Snowboard School, Team Christie, their affiliates, owners, officers, directors, shareholders, coaches, sponsors, agents or employees for any injury sustained by me, including my death, while competing in the competition. I agree not to bring any action or lawsuit against Christie Mountain Snow Area, Christie Mountain Ski School, Christie Mountain Snowboard School, Team Christie, their affiliate, owners, officers, directors, shareholders, coaches, sponsors, agents or employees for any accident, injury or damage.
